





## **Plurality Expect No Personal Impact Of ACA**


Do you think you and your family will be better off or worse off under the health reform law, or don't you think it will make much difference?


#### Who Stands To Benefit From Coverage Expansions?


#### **Picture Gets Complicated At The State Level**


## **KFF California Uninsured Panel Survey**

- 2000 randomly selected California residents:
  - Ages 19-64
  - Uninsured for at least 2 months at the time of the survey
- RDD Landline and cell phone, oversampled areas with lower-income populations
- English and Spanish
- Baseline survey: July-August 2013 (prior to open enrollment)
- Plan to follow up with SAME respondents 3 more times:
  - Spring 2014 (after close of open enrollment period)
  - Late 2014
  - Early 2015







Among California eligible uninsured: In general, how easy or difficult is it for you and your family to afford each of the following?



Among California eligible uninsured, percent who say that during the time they have been uninsured, they have done each of the following because of the cost:






## Large Majority—Including Young Adults—Say Health Insurance Is Something They Need

I'm healthy enough that I don't really need health insurance




#### At Least Half In Income Ranges Targeted By Exchange Unaware They May Qualify To Participate, Receive Subsidies

... get financial assistance from the government to help pay for health insurance as a result of the health care law, or not?







## In Medi-Cal Target Group, Half Believe They Are Eligible, Nine In Ten Would Want To Enroll

If you were told you were eligible for Medi-Cal, would you want to enroll, or not?






## Many Undocumented Uninsured Report Difficulty Affording Health Care


